LPD letter 40 was submitted, and it was

Location Department Branch – It was reported branch regular meetings were taking place, and that the branch AGM is scheduled for 23 July 2018.

Visual Effects Branch – Arrangements on organising the Post Festival, to be held in conjunction with the Post Production and Facilities Branch in Soho on 9 September

2018, were reported. Following a wide ranging discussion, it was

Branch consult their respective membership on the proposal to amalgamate the two branches.
